WAIVER FOR EXCLUSION GROUND (WEG) REQUIREMENTS

WEG requirements apply to children under fifteen (15) years of age who are not holding Philippine passports and are not accompanied by or coming to stay with a parent in the Philippines.

All applications for WEG shall be filed within **three days after arrival** and shall be signed and approved by the Head Supervisor of the Bureau of Immigration, Ninoy Aquino International Airport (NAIA) after submission of the following requirements:

1. **Acknowledged/consularized Letter Request** made under oath by both parents or legally appointed guardian addressed to the BI Commissioner for the issuance of a WEG in favor of the minor child who will be accompanied by the named travelling companion; the letter must include a duly accomplished APPLICATION FOR WAIVER FOR EXCLUSION GROUND;
2. **Acknowledged/consularized Affidavit of Consent to Travel** (or Parental Travel Permit) made under oath by both parents or legally appointed guardian, naming therein the person who will be accompanying the child to the Philippines and with whom the child will reside in the country; if the consent is given by the legally appointed guardian, the court order appointing the guardian shall be furnished the Bureau of Immigration.
3. Clear photocopy of the data page of the child's passport;
4. Clear photocopy of the data page of the parents'/legal guardian's passport/s; and
5. Payment of immigration fees.
